## Checkmate in one move offer regulations (for participants)

The offer is effective from January 18 till March 1, 2010.

### 1. Definitions

**Participant (customer)** – any company – a legal person that:

1. Answers in full all questions in the application found at [www.drweb.com/migrate\\_drweb\\_enterprise\\_suite/register/](http://www.drweb.com/migrate_drweb_enterprise_suite/register/)
2. Provides a confirmation that it owns a license for a corporate end-point security solution (with a centralized administration) from another vendor with the remaining license period (as of the submission date) at least **60 days**.
3. Receives a participant confirmation from Doctor Web.

**Customer** – any company – a legal person that fills out the participant application at [www.drweb.com/migrate\\_drweb\\_enterprise\\_suite/register/](http://www.drweb.com/migrate_drweb_enterprise_suite/register/)

**Exchange product (license)** – Dr.Web Enterprise Suite.

### 2. Offer terms

Registered participants can purchase a license for **Dr.Web Enterprise Suite** for 12 months at 40% off the price and use **Dr.Web Enterprise Suite** free of charge during the remaining period of their licenses for another anti-virus. The 40% discount is applied to the price of a Dr.Web Enterprise effective at the moment of purchase.

#### Restrictions

1. A participant can receive a free of charge license to **Dr.Web Enterprise Suite** only for the remaining period of the license from another vendor starting from the payment date for the exchange product.
2. The license term of the exchange product can be 3 years maximum.
3. Dr.Web bundles products featuring **Dr.Web Enterprise Suite** can not participate in the event.
4. The offer discount can't be added to any other discount.
5. If several products for protection of different types of objects are purchased including **Dr.Web Enterprise Suite**, the offer discount will only affect the price of a **Dr.Web Enterprise Suite** license and the number of protected workstations listed in the license of another vendor.

#### Exchange license renewal

Prices and discounts effective at the date of renewal are applied to a renewed exchange license.

### 3. Participant registration procedure

1. To participate in the offer a customer has to file a request from the promo web-site at [www.drweb.com/migrate\\_drweb\\_enterprise\\_suite/](http://www.drweb.com/migrate_drweb_enterprise_suite/).
2. Participation requests are reviewed by Doctor Web's managers.
3. In two days following a receipt of the request the customer receives a message confirming his participation in the event or rejecting the request.
4. A confirmation e-mail contains the price of a license that the customer is to pay under the offer.
5. Doctor Web reserves the right to reject a registration request if 1) at least one of the questions in the form is left unanswered 2) answers appear to be incomplete or inaccurate 3) the license for another anti-virus has expired or will expire sooner than in 60 days following the request submission date.

### 4. Exchange

A participant can exchange for **Dr.Web Enterprise Suite** under the offer via an authorized partner of Doctor Web or through the Dr.Web e-store.

#### Exchange over partners

1. A customer's request is reviewed by a manager of Doctor Web. In two working days following the receipt of the customer's request the manager is expected to approve the request or send to the participant a rejection e-mail that will provide a reason for rejection.
2. Upon approval of a request, the customer's information is forwarded to Doctor Web's partner that participates in the event.
3. After that a partner establishes contact with the customer in accordance with the offer regulations for partners.

#### Exchange through the e-store

1. A request of a customer is reviewed by a Doctor Web's e-store manager.
2. In two working days following the receipt of the customer's request a sales representative has to approve the request or send a rejection e-mail providing a reason for rejection to the customer.
3. Upon approval of a request the manager sends a message containing a link to the e-store to the customer so that the client will be able to purchase an exchange license at a discount specified in offer terms.
